# Research on the Integration Path of Ideological and Political Education and Skill Teaching in Swimming Class in Colleges and Universities

## 2. Current situation and problems of the integration of ideological and political education and skill teaching in college swimming class

### 2.1 The integration of curriculum is insufficient

First of all, the content of the course is relatively monotonous, and the swimming teaching in most colleges and universities overemphasizes the skills training, mainly teaching basic swimming skills and water safety knowledge. This evaluation system may cause teachers and students to neglect ideological and political education, and students may focus too much on the improvement of skills, and then ignore the values that the swimming course aims to cultivate in the learning process. The importance of ideological and political education in the swimming course has not been fully reflected because of the defects of the evaluation system, resulting in the students' ideological and moral level can not be comprehensively evaluated.

## 3. The path of integration of ideological and political education and skill teaching in college swimming class

To solve these problems, we need to reform the curriculum setting, the construction of teachers and the evaluation system, so as to improve the integration of ideological and political education and skill teaching in college swimming class, so as to improve the overall quality of the course.

#### 3.1 Promote the integration of curriculum and teaching content

#### 3.1.1 Improve teaching methods and means

The teaching methods of swimming courses in colleges and universities need to be reformed. Teachers can effectively combine ideological and political education with skill training through teaching methods such as situational teaching method, model teaching method, interactive teaching method, reflective teaching method, evaluation and incentive method, and comprehensively improve the teaching quality. #### 3.1.3 Optimize the curriculum

By integrating curriculum resources and optimizing teaching programs, we can effectively improve students' swimming skills and ideological and moral qualities.

First of all, the curriculum needs to combine theory with practice, and the history, culture and safety knowledge of swimming can be integrated into the theoretical teaching, so as to cultivate students' patriotic feelings and social responsibility. In practice teaching, we should

Specifically, the evaluation system should include multiple dimensions such as skill level, learning attitude, team spirit and moral character. Through diversified evaluation methods, we hope to make students realize that swimming course is not only a skill course, but also an important means to cultivate students' comprehensive quality.
